ORDER:

The Commissioner of Collegiate Education A.P., Hyderabad in his letter second read above has reported that in his Proceedings dated 6-4-2005 permission was accorded to fill up certain non-teaching posts viz., Attender (2) posts to clear the backlog Physically Handicapped vacancies. The Management has sought the approval of appointment of the Handicapped vacancies. The Management has sought the approval of appointment of the two individuals on the ground that the individuals are selected by the Disabled Welfare Department, Guntur as per the instructions issued in Memo.No.9750/DW/A2/2002, dated 2-12-2002. Further, in G.O.Ms.No.35 Education, dated 27-3-2006, Government have extended the regularization of NMRs in terms of G.O.Ms.No.212 Finance Dept., dated 22-4-1994 and also to fill up the backlog posts under SC/ST category. However, no mention was made with reference to the approval of backlog vacancies under Physically Handicapped categories. He has therefore requested the Government to clarify as to whether the selections of backlog vacancy under Physically Handicapped category by the Task Force Committee can be considered and also to clarify whether the Physically Handicapped backlog posts are also exempted from the purview of G.O. first read above.

- In the G.O. third read above, orders were issued extending the time limit for filling up of the backlog vacancies reserved for the persons with disabilities in Government Departments/ Government bodies up to 31-3-2009 and requested all the Departments of Secretariat, Heads of Departments and District Collectors to take immediate action to fill up all the vacancies with in the extended period.
- In the circumstances reported by the Commissioner of Collegiate Education A.P., Hyderabad in his letter second read above, and after careful examination of the matter, the Government hereby issue the following amendment to para 9 (A) of the orders issued in G.O. first read above.

AMENDMENT

The words "SC/ST backlog vacancies" occurring in para 9 (A) of G.O.Ms.No.35 Education, dated 27-3-2006, shall be substituted by " backlog vacancies meant for all reserved categories".
